Most unmarried undergraduates under the age of 24 are considered **dependent** for federal financial aid purposes and therefore must provide parental information on the FAFSA. If your parents have ended all financial support **and** refuse to provide their information on your FAFSA, then you may submit this petition to receive **only unsubsidized loans**. To submit this petition, you may not receive **any** financial support whatsoever from a parent, including living at home with a parent, using a vehicle owned by a parent, having a parent co-sign any loan, or receiving health or car insurance through a parent.

Pros and Cons to Submitting a FAFSA Without Parent Income Information

Pros: A federal unsubsidized loan is better than alternative/private education loans and credit cards. Some federal aid is better than no federal aid. Federal student loans do not involve checking a student's credit rating.

Cons: Only an unsubsidized loan can be awarded (the least desirable federal student loan). You will be ineligible for Pell Grant, SEOG Grant, need-based scholarships, work-study, Perkins Loans, federal subsidized loans, and Parent PLUS Loans. The amount of unsubsidized loan is limited to the annual grade level limit for dependent students (freshman \$5,500; sophomore \$6,500; junior/senior \$7,500). How to Submit a Petition for Dependent Students without Parental Help

1. Ask your parent(s) to complete page 2 of this document. Your parent(s) will need to initial each statement on page 2, sign the Petition, and provide the date when financial support ended. (If your parents refuse to complete this form, please attach a letter from a third party, such as a teacher, counselor, or cleric.)
2. Submit this form and the following attachments to the Boise State Financial Aid Office:
 - Attach a **detailed letter** that explains how you are planning on supporting yourself without parental involvement or support from July 1, 2017 to June 30, 2018.
 - Attach a **budget** with detailed sources of income and expenditures from July 1, 2017 to June 30, 2018.
3. If you have already submitted your 2017-2018 FAFSA, check here . If you have not yet submitted your FAFSA, please go online to fafsa.gov and do so now. If your petition is approved, your financial aid counselor will override your FAFSA on the federal FAFSA website so we can receive your application. If your petition is denied, or more information is needed, you will be notified by email to your BroncoMail address the reason and the next steps to take.

I certify that all information provided in my Petition for Dependent Students without Parental Help is correct and true. I understand that the decision made on the basis of this petition only affects my application for aid at Boise State University for the 2017-2018 academic year. I have attached my letter, budget, and third-party letter, if needed.

The Free Application for Federal Student Aid (FAFSA) requires parental information for most unmarried undergraduates under the age of 24. To complete this Petition, ask your parent(s) who have ended all financial support and refuse to provide information on your FAFSA to complete this page. The parent(s) information that would have been used on your FAFSA is your biological parent or your legally adoptive parent. Include your step-parent if your biological or adoptive parent has remarried. (Note: Grandparents, foster parents, and legal guardians are not considered parents for the purposes of FAFSA.)

Determine whether only one or both of your parents need to sign this form.

Only one parent's signature is required in the following circumstances:

- If your parent has never been married and does not live with your other legal parent.
- If your parent is widowed or divorced and has not remarried.
- If your parents are divorced or legally separated (and not living together), determine which parent will sign this form by the ranked criteria below:
 1. Parent you have lived with more over the past 12 months. If this does not apply then,
 2. Parent who provided more financial support over the past 12 months. If this does not apply then,
 3. Parent who provided more financial support during the most recent year you received financial support.
